



**GROSS DESCRIPTION:**

(A) Left Hallux Biopsy: Received in formalin, labeled with the patient's name, and "nail left hallux", are multiple strips/irregularly shaped fragments of nail tissue measuring 1.7 x 1.3 x 1.3 cm in aggregate. Entirely submitted in a tissue processing bag. one block.

(B) Left Second Digit Nail Biopsy: Received in formalin, labeled with the patient's name, and "nail left second digit", are multiple strips/irregularly shaped fragments of nail tissue measuring 0.7 x 0.4 x 0.3 cm in aggregate. Entirely submitted in a tissue processing bag. one block.

(C) Right Third Digit Nail Biopsy: Received in formalin, labeled with the patient's name, and "nail right third digit", are multiple strips/irregularly shaped fragments of nail tissue measuring 1.1 x 1.0 x 0.7 cm in aggregate. Entirely submitted in a tissue processing bag. one block.
